## DESCRIPTION OF THE PROGRAM

### ESTHETICIAN COURSE (Hybrid-Theory Online)

This course covers the overall subject of skin care, hair removal, make-up, and eyelash application. Successful completion of this course and passing the State Board Examination and Licensure allow the esthetician to perform all skills needed to be a Skin Care Specialist, Make-Up Artist, Hair Remover, Salon Owner, Salon Manager, Beauty Product Sales Representative, and Product Demonstrator. The course will consist of 600 clock hours which includes technical instruction and practical operations covering all practices constituting the art of skin care.

# ESTHETICIAN EDUCATIONAL MISSION AND OBJECTIVE

THE ESTHETICIAN mission and objective is to provide quality instruction which will prepare students to pass the State Board of Cosmetology Examination for their course, and prepare all students with the necessary skills and knowledge for entry level positions in the beauty industry. This course covers the overall subject of estheticians. Jade Beauty and Barber College continually monitors and maintains the quality of its program of study in accordance with the standards set forth by the State Board of Cosmetology.

# ESTHETICIAN EDUCATION OVERVIEW

Esthetician students will be taught, learn and practice on manikins heads, or on a person the following subjects:

1. Facial: Manual, electrical and chemicals forms of cleansing, scientific manipulations, packs, and masks. Electrical Facials include the use of electrical modalities, dermal lights, and electrical apparatus for facials and skin care purposes of the following
  - a. Relaxation facial, facial for dry, oily, normal and sensitive skin
  - b. Spot treatment
  - c. Micro-dermal abrasions
2. Preparation, client consultation, intake procedures, and contraindications
3. Make-up: Skin analysis, basic and corrective application, and application of false eyelashes.
  - a. Day time and night time make-up
4. Hair removal: Eyebrow shaping, hair removal techniques, hair analysis, waxing, tweezing, and manual or electrical depilatories.
  - a. Waxing and tweezing
  - b. Depilatories
5. Salon business: Communication skills, receptionist, professional ethics, salesmanship, record keeping, and client service records.
6. Health and safety: Disinfection and sanitation, safety, and customer protection.
7. Other subjects: Skin care chemistry, purpose of cosmetics, skin care. Chemical and physical changes of matter. Hazardous substances, protection from hazardous chemicals and preventing chemical injuries, ergonomics, bacteriology, communicable diseases, Material Safety Data Sheets. Human anatomy and physiology.
8. Law and regulations: The Barbering and Cosmetology Act and the Board's Rules and Regulations
9. A esthetician license will be granted by the State Board of Barber and Cosmetology of California only after students graduated from the Barber course and passed the Cosmetology Stated Board Exam with an overall average of 75%.
